CHF 1500 question on the comment about Social Work. This was resolved in curriculum committee. Social Work has wanted to add a course to a Gen Ed designation and they were told that it would be rejected in the past. CHF did not state on their proposal that there was a course close to theirs so Social work was given the go ahead to submit a request to add Gen ED to their course. This has been clarified.

**Holding** – WSU/ENGL1560 - the Executive Committee is requesting a letter of support to be sure that there is not overlap to IST1100 a Business Administration course. Pending a letter of support from Michael Stevens to Luke Fernandez, this proposal will be held.

6. Other Items

<u>Textbook AdHoc Committee</u> – Other issues coming up with this subject. This is becoming a hot topic and the policy needs to be updated to come into compliance with the way textbooks are ordered and utilized on campus.

Some course are moving toward epackets and having the course fees covers the epackets rather than the student purchasing the packet. Faculty want to propose course fees for this use, but there is no policy, they are in limbo at the moment. This needs to be pushed into action as soon as possible.
